Promote use of drones by **RBKs for soil testing: CM**

- Says this will facilitate the implementation of the 'Plant Doctor' concept successfully
- Asks officials to equip all 10,000 **RBKs** with drones
- Says more audiovisual programmes should be produced on methods of cultivation to help farmers

STRESSING on the need to use drones extensively in agriculture sector, Chief Minister Y S Jagan Mohan Reddy directed the officials to ensure that drones are also used for soil testing by RBKs.

Reviewing the activities of Agricultural Department here on Friday, the Chief Minister told them that extensive use of drones in soil testing by RBKs will also help implement 'Plant Doctor' concept successfully besides arriving at correct estimates of productivity and maintaining related data.

When the officials told him that drones were being used in arriving at estimates

of paddy productivity, he suggested that they should be used for other crops also. "Now we are using drones for spraying pesticides but they should be used for multi purposes so that it would be more helpful to the farmers," the Chief Minister said, adding that steps should be taken to equip all 10,000 RBKs with

They said that 222 farmers were trained on the use of drones under the pilot project and the department was purchasing quality drones certified by the DGCA and all safety measures were being taken while launching and using them.

The Chief Minister suggested that more audio-visual programmes should be made on the cultivating methods and they should be telecast through the RBK channel for the benefit of farmers.

Officials explained that efforts were being made to prepare the draft Bill on MSP Act-2023 for ensuring MSP for all agricultural produce and bring all aqua and dairy farmers under the Act.

Officials further said that during the last four years, 4.34 lakh acres has been additionally brought under the horticultural cultivation. The Chief Minister suggested that different types of horticultural crops used in food processing should be encour-

"There should be more cold-storage rooms, godowns and collection centres for encouraging the horticultural farmers," he said, adding that procurement of all other crops should be through RBKs, in addition to paddy. RBKs should play key role in marketing as well.

Steps also should be taken

to establish onion and tomato food processing units at places where there is more

cultivation of such crops. To help women achieve self-sufficiency, they should be encouraged to establish secondary food processing units by providing them loans under the YSR Cheyuta scheme, he said.

Officials told him that 6,000 micro units were being established to help women with the help of Cheyuta scheme. The Chief Minister said as the government was establishing drying and primary processing units and distributing agricultural utensils and machinery for farmers, all these should be linked to the RBKs for ensuring MSP, handholding them at every step and completely eliminating the role of mid-

State govt provides ownership rights to 15.21L farmers

Pattas were also distributed for 33,428 acres of dotted lands, says the Revenue Minister

MINISTER for Revenue Dharmana Prasada Rao said that the State government provided ownership rights to those who were in possession of assigned lands for the last 20 years.

He said around 15.21 lakh farmers will derive benefit with the decision of the State government. He said 33,29,000 acres of assigned land was distributed earlier, and after Independence assigned land was distributed to 19,21,000 farmers. Of them at present 15,21000 farmers will derive the benefit with the government's decision.

Speaking to mediapersons at the Secretariat here on Friday, the Minister said Jagan Mohan Reddy's government provided ownership rights to assigned land owners. He said the move will contribute 2 per cent growth to the GDP.

Anyone purchasing or forcefully taking possession of assigned lands will not be permitted and people should bring such incidents to the notice of the Revenue Department, the Minister said.

Dharmana said that the State government brought several reforms on lands through resurvey of lands. He said as a result of the resurvey, several land litigations were resolved. He said after taking up resurvey of lands, 19 lakh mutations took place. In addition, the State government also benefited farmers by removing 2.2 lakh dotted lands from 22-A list. He said pattas were distributed for 33,428 acres of dotted lands.

The Revenue Minister said the State government also stabilised 9,600 acres of island lands and distributed pattas. The Minister pointed out that the land resurvey has been taken up in Andhra

Money laundering case accused writes to Telangana Governor

SUKHESH Chandrashekar, who is the main accused in the Rs 200 crore money laundering case, has written a letter to Telangana State Governor Tamilisai Soundararajan against the ruling BRS party MLC K Kavitha and State Minister KT Ramarao. He claimed that Kavitha and KTR's close friends were mounting pressure on him to give evidence he has against them. He also claimed that two leaders were asking him to give the evidence of the statements given to the ED against Kavitha. He also

claimed that Kavitha and



KTR were offering Rs 100 crore cash, a piece of land at Shamshabad and an assembly seat if he gave evidence.

"I have evidence of transactions worth around Rs 200 crore. There is a recording of the entire WhatsApp chat between Kavita and me. This evidence has al-

ready been given to the ED in the form of section of 65-B certificate. I took Rs 15 crore cash from Kavita and handed it over to those, who are related to Delhi CM Arvind Kejriwal," he said in his letter. Sukhesh urged the Governor to seek a CBI inquiry into the issue.
